MINUTES

The regular meeting of the Upshur County Emergency Services District No. 1 Board of Directors was held on April 12, 2021, at the Gilmer Fire Station, 120 Henderson, Gilmer, Texas.

- 1) Open meeting. The meeting was opened at 7:00 p.m. by Marc Nichols.
- 2) <u>Call to order</u>. Marc Nichols called the meeting to order. Prayer was led by Gaston DeBerry, III.
- 3) <u>Determine quorum present</u>. Marc Nichols determined a quorum was present with Gary Smith being absent.
- **4)** Read and approve the minutes from the Regular meeting held March 8, 2021. Motion was made by Gaston DeBerry, III and second by David Tackett to approve the minutes from the Regular meeting held March 8, 2021. Motion carried 4-0. Unanimous vote in favor.
- 5) <u>Public Comment</u>. Mike Fennell notified the Board that the Glenwood VFD had a jaws unit available to service the other departments if needed.
- 6) <u>Discussion regarding recruitment/retention program countywide monthly training.</u>
 There was discussion regarding the training to be held May 8th at the Gilmer Civic Center.
- 7) Discuss and take action regarding payment for training materials for EVOC course to be held in May. Motion by Gaston DeBerry, III with a second by David Tackett to reimburse Michael Kuza for materials purchased up to \$300.00. Motion carried 3-1 with Michael Kuza abstaining.
- 8) Discuss and take action regarding repairs to Lafayette VFD trucks. Motion by Michael Kuza with a second by Gaston DeBerry, III to have the truck looked at to see if a packing gland is bad and if so, to have it fixed. Motion carried 4-0. Unanimous vote in favor.
- 9) Discuss and take action on de-annexing part of ESD#1 to create ESD#2 as per boundaries set. It was discussed that the new ESD#2 would include New Diana and Ore City school districts and a portion of Pittsburg ISD. It would include the Diana and Ore City Fire Departments as well as the New Mountain VFD. Gaston DeBerry, III announced his resignation from the ESD#1 in order to serve on the new ESD#2 board. It was further announced that the Upshur County Commissioners Court would be selecting the new

members for the ESD#2 at the April 15, 2021 meeting. Motion by David Tackett with a second by Gaston DeBerry, III to approve the de-annexation from ESD#1 to create ESD#2 as per boundaries. Motion carried 4-0. Unanimous vote in favor.

- 10) Pay the City of Gilmer for dispatching services for the month of March, 2021. Motion by Gaston DeBerry, III and second by David Tackett to pay the City of Gilmer for dispatching services for the month of March, 2021 in the amount of \$3,000.00. Motion carried 4-0. Unanimous vote in favor.
