#### MINUTES

The regular meeting of the Upshur County Emergency Services District No. 1 Board of Commissioners was held on January 9, 2023, in the Upshur County Courtroom, Upshur County Courthouse, 100 W. Tyler Street, Gilmer, Texas.

# The District considered and acted upon the following matters:

- 1) Open meeting. The meeting was opened at 7:04 p.m. by Michael Kuza.
- 2) <u>Call meeting to order, Roll Call of Board and establish quorum</u>. Michael Kuza called the meeting to order. Michael Kuza determined a quorum was present with Michael Kuza, Scott Mischnick, Cloddie Henson, and Kenny Southwell present. Bobby Jenkins arrived at 7:18 p.m.
- 3) <u>To receive public comment</u>. Ray Cook announced his support of the Harmony Fire Station as well as West Mountain, Simpsonville, and other members in attendance. Chief Taylor thanked those members of the Board that submitted their CE hours to him per his public information request.

## 4) Election of Officers:

President: Cloddie Henson nominated Michael Kuza for President. Michael Kuza elected with 3 votes. Michael Kuza abstained.

Vice-President: Scott Mischnick nominated Bobby Jenkins for Vice-President. Bobby Jenkins elected with 4 votes.

Secretary/Assistant Treasurer: Cloddie Henson nominated Scott Mischnick for Secretary/Assistant Treasurer. Scott Mischnick nominated Kenny Southwell for Secretary/Assistant Treasurer. 1 vote for Scott Mischnick; 2 votes for Kenny Southwell. Kenny Southwell elected with 2 votes. Kenny Southwell abstained.

Treasurer/Assistant Secretary: Cloddie Henson nominated Scott Mischnick for Treasurer/Assistant Secretary. Scott Mischnick elected with 3 votes. Scott Mischnick abstained.

5) To discuss and take action regarding policies for ESD #1. Motion was made by Kenny Southwell and second by Scott Mischnick to adopt the policy as read regarding public comments procedure. Motion carried 4-0. Unanimous vote in favor.

Cloddie Henson made a motion with a second by Kenny Southwell to adopt the policy as read regarding open records request procedure. Motion carried 4-0. Unanimous vote in favor.

- 6) To read and take action on approval of the minutes from the Special meeting held November 17, 2022; Regular meeting held December 12, 2022; Special meeting held December 12, 2022; and Special meeting held December 16, 2022. Unanimous vote in favor.

- 9) To discuss board members attendance for SAFE-D conference to be held February 2-4, 2023 in Round Rock, Texas. Michael Kuza entertained a motion that all members attend the SAFE-D conference. Cloddie Henson seconded the motion. Motion carried 5-0.
- 10) To discuss and take action if necessary regarding the Harmony VFD fire station. Scott Mischnick made a motion to proceed with the build contingent upon a deed being drawn up to transfer the property to the Upshur County Emergency Services District #1. Kenny Southwell made a motion to amend Scott's motion. Motion to amend carried 4 for with 1 against. Kenny Southwell made a motion with a second by Scott Mischnick to proceed with the build not to exceed \$472,000.00 and contingent upon a deed being drawn up to transfer the property to the Upshur County Emergency Services District #1 and with provisions to discuss value engineering from this date going forward at future meetings. Motion carried 4 for and 1 against.
- 11) Presentation by Matt Burnett regarding sales tax election.
- **To pay the City of Gilmer for dispatching services for the month of December, 2022.**Motion by Kenny Southwell and second by Bobby Jenkins to pay the City of Gilmer for dispatching services for the month of December, 2022 in the amount of \$3,000.00. Motion carried 5-0. Unanimous vote in favor.
