MINUTES

The regular meeting of the Upshur County Emergency Services District No. 1 Board of Commissioners was held on April 10, 2023, at the East Mountain Fire Station, 107 Municipal Drive, Gilmer, Texas 75644.

- 1) Open meeting. The meeting was opened at 7:03 p.m. by Michael Kuza.
- 2) <u>Call meeting to order, Roll Call of Board and establish quorum</u>. Michael Kuza called the meeting to order. Michael Kuza determined a quorum was present with Michael Kuza, Scott Mischnick, Cloddie Henson, and Kenny Southwell present. Bobby Jenkins arrived at 7:12 p.m.
- 3) <u>Public comment</u>. Michael Cole with TEEX spoke regarding all the services available to fire departments. Bracy Sweat with West Mountain VFD asked the Board to consider deferring the \$5,000.00 payment for the loan. Jason With Ewell VFD announced a flag retirement set for April 15th at the Senior Center.
