## MINUTES

The regular meeting of the Upshur County Emergency Services District No. 1 Board of Commissioners was held on July 10, 2023, in the Upshur County Courtroom, Upshur County Courthouse, 100 W. Tyler Street, Gilmer, Texas.

## The District considered and acted upon the following matters:

- 1) Open meeting. The meeting was opened at 7:00 p.m. by Michael Kuza.
- 2) <u>Call meeting to order, Roll Call of Board and establish quorum</u>. Michael Kuza called the meeting to order. Michael Kuza determined a quorum with Michael Kuza, Scott Mischnick, Kenny Southwell and Cloddie Henson being present. Bobby Jenkins arrived at 7:36 p.m.
- 3) <u>Public comment</u>. Michael Kuza made an announcement that he had a list of vehicles insured with the ESD. He requested help from the departments with matching the VIN#s to the location of the vehicles. He also announced that an inventory had been completed at the East Mountain, West Mountain, and Pritchett departments. Kenny Southwell requested suggestions from those in attendance regarding the best month to schedule a 300 class. It was determined that January would be a good month to schedule this class.

- 9) <u>Discuss and take action regarding budget template and budget deadline.</u> Michael Kuza will send the budget template and questionnaire to the departments. No action.

- 11) <u>Discuss and take action to pay bills for Bettie VFD as submitted and approved</u>. Cloddie Henson made a motion with a second by Kenny Southwell to pay the bills as submitted and approved. It was brought to the attention of the Board that the bills were not received by deadline. Motion failed with 2 for and 2 against with one abstaining. No further action.
- 12) <u>Discuss and take action to pay bills for East Mountain VFD (station #1 and station #2) as submitted and approved</u>. Motion by Cloddie Henson to pay the bills as submitted. It was brought to the attention of the Board that the bills were not received by deadline. Motion failed for lack of second. No further action.
- **Discuss and take action to pay bills for Ewell VFD as submitted and approved**. Motion by Kenny Southwell with a second by Bobby Jenkins to pay Ewell VFD bills in the amount of \$7,210.00. Motion carried 5-0. Unanimous vote in favor.
- 14) <u>Discuss and take action to pay bills for Harmony VFD as submitted and approved</u>. Motion by Scott Mischnick and second by Cloddie Henson to pay Harmony VFD bills in the amount of \$478.88. Motion carried 5-0. Unanimous vote in favor.
- 15) <u>Discuss and take action to pay bills for Pleasant Grove VFD as submitted and approved</u>. Motion by Bobby Jenkins and second by Kenny Southwell to pay Pleasant Grove VFD bills in the amount of \$4,697.23. Motion carried 4-0 with Scott Mischnick abstaining.

- **Discuss and take action to pay bills for Pritchett VFD as submitted and approved.**Motion by Scott Mischnick and second by Kenny Southwell to pay Pritchett VFD bills in the amount of \$957.59. Motion carried 5-0. Unanimous vote in favor.
- 17) <u>Discuss and take action to pay bills for Simpsonville VFD as submitted and approved</u>. No bills submitted.
- **Discuss and take action to pay bills for West Mountain VFD as submitted and approved.**Motion by Scott Mischnick and second by Kenny Southwell to pay West Mountain VFD bills in the amount of \$566.70. Motion carried 5-0. Unanimous vote in favor.
- **19)** Discuss and take action on any insurance claim pay outs to rural departments. No action taken.
- **20)** <u>Discuss and take action on any grant reimbursement requests submitted</u>. No action taken.
- **Discuss and take action on any budget amendments**. No budget amendments. Bobby Jenkins advised the Board that East Mountain VFD needed a check for ½ of the invoice for the work on the door at their station as this matter was approved at the meeting held June 12, 2023. A check was written to Cutting Edge Fabrication in the amount of \$9,375.00 as ½ of the invoice provided. East Mountain VFD is to furnish the ESD with a receipt showing payment.
- **22)** <u>Items to be considered for next month's agenda</u>. Items #7 and Budget Discussion (this will be on each agenda until budget adopted)
- 23) Adjournment. Meeting adjourned at 7:51 p.m.
